## REVIEW REPORT

To

The Board of Directors, Vardhman Holdings Limited, Ludhiana.

We have reviewed the accompanying statement of unaudited financial results of Vardhman Holdings. Limited for the period ended 30<sup>th</sup> June, 2018 except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors/ committee of Board of Directors.
