Notes:

- 1 The above Unaudited Financial Results as reviewed by the Audit Committee have been approved at the meeting of the Board of Directors held on 1 February 2019 and have been subjected to Limited Review by the Statutory Auditors. The review report of the Statutory Auditors is being filed with the BSE and NSE. - 2 The Company is engaged in the single operating segment "Steel".
- 3 Revenue from operations for the nine months ended 31 December 2018 is not comparable with corresponding previous period since the same is net of Goods and Service Tax ("GST") whereas excise duty form part of revenue till 30 June 2017.
- 4 The Company is eligible for incentives under the Mega Project Policy of the Punjab State Government for its expansions completed up to March 31, 2016. Though the plant has been commissioned but the benefits have not been considered in the above results as the same is pending for sanction by appropriate authority.
- 5 Effective 01 April 2018, the Company adopted Ind AS 115 "Revenue from Contracts with Customers" using the cumulative effect method which is applied to contracts that were not completed as of 01 April 2018. Accordingly, the comparatives have not been retrospectively adjusted. There is no effect on adoption of Ind AS 115 on the financial results.

1. We have reviewed the accompanying statement of unaudited financial results ('the financial results') of **Vardhman Special Steels Limited** ('the Company') for the quarter ended 31 December 2018 and the year-to-date results for the period from 1 April 2018 to 31 December 2018 attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations').
2. These financial results are the responsibility of the Company's Management and has been approved by the Board of Directors on 1 February 2019. Our responsibility is to issue a report on these financial results based on our review.
3. We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, *Review of Interim Financial Information Performed by the Independent Auditor of the Entity* specified under section 143(10) of the Companies Act, 2013. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial results are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
4. The financial results for the quarter ended 30 June 2018, year ended 31 March 2018 and quarter and nine months ended 31 December 2017 included in these financial results were reviewed/audited by the predecessor auditor of the Company, whose report dated 11 August 2018, 27 April 2018 and 3 February 2018 respectively expressed unmodified opinions, and have been furnished to us and have been relied upon by us for the purpose of our review of these financial results. Our conclusion is not modified in respect of these matter.


